NORTH AVENUE

(i) Traffic Regulation (Consolidation) Order 2009 (North Avenue Variation) Order 2021

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Consolidation Order").
2. The effect of the proposed Order is to introduce a no waiting at any time restriction (double yellow lines) on the following lengths of road -

North Avenue –

- (a) both sides, from 22 metres south east of Salters Road south eastwards for 17.4 metres;
- (b) south west side - from 71 metres south east of Salters Road south eastwards for 36 metres

(ii) (On Street Parking Places) Order 2009 (North Avenue Variation) Order 2021

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the 2009 On Street Order").
2. The effect of the proposed Order is to -
 - (a) remove sections of existing permit holders parking place on North Avenue. They will be replaced by the proposed double yellow lines specified in section (i) 2 above. The remaining sections of permit holders parking place will be as follows –
 - (1) **North Avenue** – north east side, from 22 metres south east of Salters Road north westwards for 5.5 metres (currently extends from 2 metres north east of Back Broomfield Road north westwards for 17 metres), and
 - (2) **North Avenue** – north east side, from 6 metres north west of Broomfield Road north westwards for 12.3 metres (currently extends from 2 metres north east of Broomfield Road north westwards for 17 metres), and
 - (3) **North Avenue** – south west side, from 21 metres north west of Furze field Road north westwards for 132.5 metres (currently

extends from 21 metres north west of its junction with Furze field Road north westwards for 219 metres).

- (b) introduce a new section of permit holders parking place on the following length of road. The parking place will operate between the hours of 9.30am – 11.30am, 1.30pm – 3.30pm and 5.00pm – 7.00pm Monday to Saturday -

North Avenue - south west side, from 39.4 metres south east of Salters Road south eastwards for 31.6 metres.

(iii) Proposed Construction of Road Humps – North Avenue

1. **NOTICE IS HEREBY GIVEN** in accordance with Section 90C of the Highways Act 1980 that the Council of the City of Newcastle upon Tyne in exercise of its powers under Section 90A of the Highways Act 1980 proposes to construct road humps complying with the Highways (Road Humps) Regulations 1999 in **North Avenue**.
2. The details of the road humps are as follows -

Nature – Road Humps

Locations (to the centre of the road humps –

- (a) **North Avenue** - 9.5 metres north west of its junction with Broomfield Road
- (b) **North Avenue** - 9 metres north west of its junction with Mayfield Road
- (c) **North Avenue** - 48 metres south east of its junction with Mayfield Road
- (d) **North Avenue** - 9.5 metres north west of its junction with West Avenue

Dimensions -

Width – full width of carriageway

Height - 85mm

Ramp Gradients – 1:10

Length along the carriageway to be 4.445m in all cases.
