

**CITY OF NEWCASTLE UPON TYNE  
(ON STREET PARKING PLACES) ORDER 2009  
(TANKERVILLE TERRACE AREA VARIATION) ORDER 2020**

The Council of the City of Newcastle upon Tyne in exercise of its powers under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other powers them enabling it in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:-

1. This Order shall come into operation on XXXXXXXXXXXX 20XX and may be cited as the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 (Tankerville Terrace Area Variation) Order 2020.
2. The City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the 2009 Order") is hereby further varied by –
  - (a) the deletion of the wording specified in Column 3 of Schedule 11 thereto in relation to Parking Place Nos. 11.1, 11.24, 11.25, 11.27, 11.28, 11.44, 11.45, 11.52, 11.54, 11.66, 11.70, 11.71, 11.174, 11.175, 11.176, 11.177, 11.178, 11.179, 11.180, 11.372, 11.373, 11.509, 11.510, 11.511, 11.512, 11.559, 11.630, 11.631, 11.632, 11.768, 11.769, 11.770, 11.771, 11.915, 11.916, 11.917, 11.918, 11.919, 11.920, 11.921 and 11.922 and the addition, by way of replacement, of the wording specified in Schedule 1 to this Order,
  - (b) the addition into Schedule 11 thereto of the new Parking Place specified in Schedule 2 to this Order,
  - (c) the addition into Schedule 14 thereto of the details specified in Schedule 3 to this Order,
  - (d) the addition into Burdon Terrace in Schedule 14 thereto of a reference to "Jesmond United Reform Church (2 Charity parking permits only – free of charge)", and
  - (e) the addition into Parking Zone J1 in Schedule 15 thereto of a reference to Parking Place No. 11.xxx
3. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation or order made or having effect as if made under the 1984 Act.
