

**CITY OF NEWCASTLE UPON TYNE
(ON STREET PARKING PLACES) ORDER 2009
(BACK HIGH STREET WEST/BACK HEDLEY STREET WEST AREA VARIATION)
ORDER 2020**

The Council of the City of Newcastle upon Tyne in exercise of its powers under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other powers then enabling it in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:-

1. This Order shall come into operation on XXXXXXXXXXXX 20 and may be cited as the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 (Back High Street West/Back Hedley Street West Area Variation) Order 2020.
2. The City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the 2009 Order") is hereby further varied by -
 - (a) the deletion of Parking Place No. 11.51 from Schedule 11 thereto;
 - (b) the addition into Schedule 11 thereto of the new Parking Places specified in Schedule 1 to this Order;
 - (c) the deletion of Parking Place No. 13.10 from Schedule 13 thereto;
 - (d) the addition into Schedule 13 of the new Parking Place specified in Schedule 2 to this Order;
 - (e) the addition into Schedule 14 thereto of the details specified in Schedule 3 to this Order;
 - (f) the deletion from Parking Zone G3 in Schedule 15 thereto of the references to Parking Place Nos. 11.51 and 13.10; and
 - (g) the addition into Parking Zone G3 in Schedule 15 of a reference to Parking Place Nos. 11.xxx, 11.xxx, 11.xxx and 13.xxx.
3. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation or order made or having effect as if made under the 1984 Act.
