CITY OF NEWCASTLE UPON TYNE TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009 (STOWELL STREET VARIATION) ORDER 2020

The Council of the City of Newcastle upon Tyne in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2), 29 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as "the Act") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. The City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009, as amended, ("the Order") is hereby further varied by
 - (a) after Article 59 there shall be inserted a new Article 59A as follows
 - "59A Save as provided in Article 65 (g) of this Order no person shall, except upon the direction or with the permission of a uniformed police officer or traffic warden, cause or permit any vehicle to wait between the hours of 11.00 am and 3.00 pm on any day on any of the roads, sides of roads, lengths of roads or sides of lengths of roads, as the case may be, specified in Schedule 59A to this Order, for the purpose of enabling goods to be loaded onto or unloaded from the vehicle"; and
 - (b) after Schedule 59 there shall be inserted a new Schedule 59A as follows -

"SCHEDULE 59A

Article 59A

PROHIBITION OF LOADING AND UNLOADING BETWEEN 11.00AM AND 3.00PM ALL DAYS"

- (c) the addition into the new Schedule 59A of the item specified in the Schedule to this Order.
- 2. In this Order, unless otherwise specified, references to Articles and Schedules shall be construed as references to Articles and Schedules of the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009.
- The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
- 4. This Order shall come into operation on xxxxxxxxxxx 20xx, and may be cited as the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 (Stowell Street Variation) Order 2020.
