

**CITY OF NEWCASTLE UPON TYNE
TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009
(GROVE PARK AREA VARIATION) ORDER 2017**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 (“the 2009 Order”). Note – the Council is currently in the process of making a new Consolidation Order (“the new Order”). If the new Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Order.
2. The effect of the proposed Order is to introduce a **prohibition of waiting at any time restriction** (double yellow lines) on the following lengths of road –
 - (a) **Grove Park Avenue –**
 - (i) south east side, from Grove Park Crescent north eastwards for 12 metres;
 - (ii) north west side, from Grove Park Crescent north eastwards for 10 metres;
 - (iii) east side, from St Nicholas Avenue southwards then eastwards for 23 metres;
 - (iv) west side, from St Nicholas Avenue southwards for 21 metres,
 - (b) **Grove Park Crescent –**
 - (i) both sides, from The Grove north westwards for 11 metres;
 - (ii) both sides, from St Nicholas Avenue southwards for 22 metres;
 - (iii) both sides of the section leading to St Nicholas Avenue, from Grove Park Crescent north westwards for 10 metres;
 - (iv) west side, from 9 metres south of Grove Park Square northwards for 18 metres;
 - (v) north west side, from 10 metres south west of Grove Park Crescent (section leading to St Nicholas Avenue) north eastwards for 20 metres;
 - (vi) north east side, from 10 metres south east of Grove Park Avenue north westerly for 20 metres,
 - (c) **Grove Park Square –** both sides, from Grove Park Crescent westwards for 10 metres,
 - (d) **St Nicholas Avenue –**
 - (i) south side, from 10 metres west of Grove Park Avenue eastwards for 20 metres;
 - (ii) south side, from 15 metres west of Grove Park Crescent eastwards for 30 metres,
 - (e) **The Grove -** north west side, from 14 metres south west of Grove Park Crescent north eastwards for 28 metres.

3. Documents giving more detailed particulars of the Order (including draft Order, map and a statement of the Council's reasons for proposing to make the Order), and the 2009 Order, may be inspected free of charge at –
