## **GIBSON STREET**

- (i) Traffic Regulation (Consolidation) Order 2009 (Gibson Street Variation)
  Order 2017
- NOTICE IS HEREBY GIVEN that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the Consolidation Order"). Note the Council are currently in the process of making a new Consolidation Order ("the new Order"). If the new Order is made before the proposed Order, then the proposed Order will become an amendment to the new Order.
- 2. The effect of the proposed Order is to -
  - (i) increase the length of two existing sections of no waiting at any time restriction (double yellow lines) on the east side of **Gibson Street** so that they extend as follows -
    - (a) from New Bridge Street to 14.7 metres south of Gibson Street (Northern Access to Melbourne Court car park) (currently extends from New Bridge Street southwards for 58 metres); and
    - (b) from 7.3 metres north of Gibson Street (Southern Access to Melbourne Court car park) southwards for 17.5 metres (currently extends from 87 metres south of New Bridge Street southwards for 14 metres);
  - (ii) revoke the existing no waiting between 8am and 6.30pm any day restriction on **Gibson Street** east side, from 58 metres south of New Bridge Street southwards for 29 metres.
- (ii) (On Street Parking Places) Order 2009 (Gibson Street Variation) Order 2017
- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the On Street Order"). Note the Council are currently in the process of making a new On Street Parking Places Order ("the new Order"). If the new Order is made before the proposed Order, then the proposed Order will become an amendment to the new Order.
- 2. The effect of the proposed Order is to designate the following length of road as a parking place with parking meters for use by motor cars, invalid carriages and motor cycles. The parking charge, which is payable between 8am and 6.30pm all days will be 60p per hour and the maximum period of stay is 24 hours. Permit

holders with valid permits for the OB3 Parking Zone will be exempt from the charge –

(a) Gibson Street – east side, from 14.7 metres south of Gibson Street (Northern Access to Melbourne Court car park) to 7.3 metres north of Gibson Street (Southern Access to Melbourne Court car park)
