UNION STREET AND INGHAM PLACE

(i) (On Street Parking Places) Order 2009 (Union Street and Ingham Place Variation) Order 2018

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the On Street Order"). (Note – the Council are in the process of making a new On Street Order ("the new Order"). If the new Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Order).
2. The effect of the proposed Order is to designate the following lengths of road as **time limit parking places**. The hours of operation will be 8am to 6.30pm Monday to Friday. Waiting will be permitted for up to 2 hours with no return for 6 hours. Permit holders with valid permits for the OB1 Parking Zone will be exempt from the time limit -
 - (a) **Ingham Place** – both sides, from 13 metres south of Union Street southwards for 28 metres;
 - (b) **Union Street** – north side, from 20 metres west of Stoddart Street westwards for 40 metres.

Note: permits will be available to the following properties: Units 1B, 2B, A1-A3 (cons), A4 and A5 Union Street and Hire Station, Union Street which are occupied by a business or charity (a maximum limit applies). Details of permit charges/issue/renewal, conditions of use, discounts and types of permit are contained in the On Street Order.

(ii) Traffic Regulation (Consolidation) Order 2009 (Union Street and Ingham Place Variation) Order 2018

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the Consolidation Order"). (Note – the Council are in the process of making a new Consolidation Order ("the new Order"). If the new Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Order).
2. The effect of the proposed Order is -
 - (a) to introduce a **no waiting at any time restriction** (double yellow lines) on the following the lengths of road –
 - (i) **Ingham Place** – both sides, for its entire length (except at designated parking places);

- (ii) **Union Street** – both sides, from Stoddart Street westwards for its remaining length (except at designated parking places);
- (b) to re-describe an existing waiting restriction on Union Street to clarify the length of road that it applies to. Note – this is an administrative exercise only and there will be no change on the ground.
