# CITY OF NEWCASTLE UPON TYNE TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009 (CHERRYBURN GARDENS AREA VARIATION) ORDER 2018

- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Order"). Note the Council is in the process of making a new Consolidation Order ("the new Order"). If the new Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Order.
- 2. The effect of the proposed Order is to introduce a **prohibition of waiting at any time restriction** (double yellow lines) on the following lengths of road –

#### (a) Auburn Gardens –

- (i) both sides, from Back Fenham Hall Drive North southwards for 8 metres:
- (ii) both sides, from Redewater Road southwards for 8 metres;
- (iii) both sides, from Back Redewater Road South northwards for 8 metres;
- (iv) both sides, from Fenham Hall Drive northwards for 11 metres,

#### (b) Back Auburn Gardens East -

- (i) both sides, from Back Redewater Road South southwards for 8 metres;
- (ii) both sides, from Ravenside Road northwards for 8 metres,

### (c) Back Cherryburn Gardens East -

- (i) both sides, from Back Fenham Hall Drive North northwards for 8 metres;
- (ii) both sides, from 8 metres south of Ravenside Road northwards for 16 metres:
- (iii) both sides, from Back Redewater Road South southwards for 8 metres,

#### (d) Back Fenham Hall Drive North -

- (i) both sides, from Kingsway eastwards for 8 metres;
- (ii) both sides, from 8 metres west of Powburn Gardens eastwards for 18 metres:
- (iii) both sides, from 8 metres west of Simonburn Avenue eastwards for 16 metres;
- (iv) both sides, from 8 metres west of Cherryburn Gardens eastwards for 16 metres;
- (v) both sides, from Auburn Gardens westwards for 8 metres;
- (vi) north side, from 7 metres west of Back Powburn Gardens East eastwards for 14 metres:
- (vii) north side, from 7 metres west of Back Simonburn Avenue East eastwards for 14 metres;

(viii) north side, from 7 metres west of Back Cherryburn Gardens East eastwards for 14 metres,

### (e) Back Powburn Gardens East –

- (i) both sides, from Back Redewater Road South southwards for 8 metres:
- (ii) both sides, from Back Fenham Hall Drive North northwards for 8 metres,

#### (f) Back Redewater Road South -

- (i) both sides, from Back Auburn Gardens East westwards for 8 metres;
- (ii) both sides, from 8 metres west of Simonburn Avenue eastwards for 16 metres:
- (iii) both sides, from Back Powburn Gardens East eastwards for 8 metres:
- (iv) both sides, from 8 metres west of Auburn Gardens eastwards for 16 metres:
- (v) south side, from 8 metres west of Back Simonburn Avenue East eastwards for 16 metres;
- (vi) south side, from 24.5 metres east of Back Simonburn Avenue East eastwards for 6.5 metres;
- (vii) south side, from 8 metres west of Back Cherryburn Gardens East eastwards for 16 metres,

## (g) Back Simonburn Avenue East -

- (i) both sides, from 8 metres south of Ravenside Road northwards for 16 metres,
- (ii) both sides, from Back Fenham Hall Drive North northwards for 8 metres:
- (iii) both sides, from Back Redewater Road South northwards for 8 metres,

## (h) Cherryburn Gardens –

- (i) both sides, from Fenham Hall Drive northwards for 10 metres;
- (ii) west side, from Back Fenham Hall Drive North southwards for 8 metres;
- (iii) east side, from Back Fenham Hall Drive North southwards for 6 metres,

#### (i) Fenham Hall Drive -

- (i) north side, from 15 metres west of Kingsway eastwards for 48 metres:
- (ii) north side, from 10 metres west of Powburn Gardens eastwards for 18 metres:
- (iii) north side, from 8.5 metres west of Simonburn Avenue eastwards for 16.5 metres;
- (iv) north side, from 36 metres west of Kingsway eastwards for 44.5 metres:

(v) north side, from 8 metres west of Kingsway eastwards for 38 metres,

## (j) Kingsway –

- (i) east side, from 8 metres north of Back Fenham Hall Drive North southwards for 13 metres;
- (ii) both sides, from Fenham Hall Drive northwards for 11 metres,

## (k) Powburn Gardens -

- (i) both sides, from Redewater Road southwards for 8 metres;
- (ii) both sides, from Back Fenham Hall Drive North northwards for 7 metres:
- (iii) both sides, from Fenham Hall Drive northwards for 10 metres;
- (iv) west side, from Back Fenham Hall Drive North southwards for 7 metres;
- (v) west side, from 8 metres north of Back Fenham Hall Drive North southwards for 14 metres:
- (vi) east side, from 7 metres north of Back Fenham Hall Drive North southwards for 12 metres;
- (vii) east side, from Back Fenham Hall Drive North northwards for 5 metres,

## (I) Ravenside Road –

- (i) both sides, from Simonburn Avenue eastwards for 8 metres;
- (ii) both sides, 25.9 metres east of Back Simonburn Avenue East eastwards for 6.5 metres:
- (iii) both sides, from 26.6 metres east of Back Cherryburn Gardens East eastwards for 6.5 metres;
- (iv) both sides, from Wingrove Road North westwards for 10 metres;
- (v) north side, from 8 metres west of Back Simonburn Avenue East eastwards for 13 metres;
- (vi) north side, from 8 metres west of Back Cherryburn Gardens East eastwards for 13 metres:
- (vii) north side, from 8 metres west of Back Auburn Gardens East eastwards for 13 metres:
- (viii) south side, from 5 metres west of Back Simonburn Avenue East eastwards for 13 metres;
- (ix) south side, from 5 metres west of Back Cherryburn Gardens East eastwards for 13 metres,

#### (m) Redewater Road -

- (i) south side, from 10 metres west of Powburn Gardens eastwards for 20 metres;
- (ii) south side, from 10 metres west of Simonburn Avenue eastwards for 20 metres;
- (iii) south side, from 10 metres west of Auburn Gardens eastwards for 20 metres;
- (iv) both sides, from Wingrove Road North westwards for 15 metres,

## (n) Simonburn Avenue –

- (i) both sides, from Redewater Road northwards for 8 metres;
- (ii) both sides, from Fenham Hall Drive northwards for 10 metres;
- (iii) west side, from 8 metres south of Back Redewater Road South northwards for 13 metres;
- (iv) west side, from 7 metres south of Back Fenham Hall Drive North northwards for 12 metres;
- (v) east side, from 5 metres south of Back Redewater Road South northwards for 13 metres;
- (vi) east side, from 6 metres south of Ravenside Road northwards for 14 metres:
- (vii) east side, from 5 metres south of Back Fenham Hall Drive North northwards for 12 metres,

# (o) Wingrove Road –

- (i) west side, from 10 metres south of Ravenside Road northwards for 20 metres;
- (ii) west side, from 15 metres south of Redewater Road northwards for 30 metres.
- 3. Documents giving more detailed particulars of the Order (including draft Order, map and a statement of the Council's reasons for proposing to make the Order), and the 2009 Order, may be inspected free of charge at
