## **OSBORNE ROAD**

- (a) Traffic Regulation (Consolidation) Order 2009 (Osborne Road Variation)
  Order 2018
- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Order"). (Note the Council are considering making a new Consolidation Order ("the new Order"). If the new Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Order).
- 2. The effect of the proposed Order is to -
  - (a) increase lengths of existing no waiting at any time restriction (double yellow lines) on Osborne Road so that they extend as follows
    - (i) east/north side, from 96 metres south of Jesmond Dene Road southwards for 61 metres (currently extends from 105 metres south of Jesmond Dene Road southwards for 26 metres); and
    - (ii) west/south side, from Jesmond Dene Road southwards for 131 metres (currently extends from Jesmond Dene Road southwards for 77 metres and 105 metres south of Jesmond Dene Road southwards for 25 metres);
  - (b) introduce a prohibition of driving onto and then parking on the footways and verges restriction on the following lengths of Osborne Road
    - (i) east/north side, from 82 metres south of Jesmond Dene Road southwards for 14 metres; and
    - (ii) west/south side, from 131 metres south of Jesmond Dene Road southwards for 44 metres.
- (b) On Street Parking Places Order 2009 (Osborne Road Variation) Order 2018
- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the On Street Order"). (Note the Council are considering making a new On Street Order ("the new Order"). If the new Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Order).
- 2. The effect of the proposed Order is to add property numbers 225 263 incl. (odd numbers only) to the Properties eligible to apply for parking permits for Parking Zone J2.

Resident parking permits will be available to eligible residential properties within the above property numbers (a maximum of 2 per property). Visitor permits can also be issued to eligible residential properties (a maximum of one per property). (Permits may also be available (if they would cause no unreasonable detriment to resident parking) for any property within the above property numbers occupied by a business or charity (a maximum of 10 permits per business or charity).
