

**CITY OF NEWCASTLE UPON TYNE
TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009
(BELLS CLOSE AREA VARIATION) ORDER 2018**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 (“the 2009 Order”). Note – the Council are considering making a new Consolidation Order (“the new Order”). If the new Order is made before the proposed Order, then the proposed Order will become an amendment to the new Order.
2. The effect of the proposed Order is to -
 - (1) introduce a prohibition of waiting at any time restriction (double yellow lines) on the following lengths of road –
 - (a) **Bells Close** – both sides, from Scotswood Road northwards then eastwards for 80 metres;
 - (b) **Neptune Road** – both sides, from Scotswood Road northwards for 50 metres;
 - (c) **Scotswood Road** –
 - (i) north side, from Neptune Road westwards for 107 metres;
 - (ii) south side, from 20 metres west of St Georges Terrace eastwards for 40 metres;
 - (2) revoke (remove) the existing prohibition of waiting at any time restriction (double yellow lines) on the following lengths of **Front Street, Lemington** –
 - (i) north side, from 18 metres west of St Georges Terrace eastwards for 75 metres;
 - (ii) south side, from 20 metres west of St Georges Terrace eastwards for 40 metres.
3. Documents giving more detailed particulars of the Order (including draft Order, map and a statement of the Council’s reasons for proposing to make the Order), and the 2009 Order, may be inspected free of charge at –

Thursday and 10am and 5pm on Friday (closed on Monday and Wednesday);

- (b) Customer Services, Central Library, Charles Avison Building, 33 New Bridge Street West, Newcastle upon Tyne, NE1 8AX between 10am and 4.30pm Monday to Friday);
- (c) Newcastle Civic Centre, Barras Bridge, Newcastle upon Tyne, NE1 8QH between 9am and 4.30pm Monday to Friday.
