- NOTICE IS HEREBY GIVEN that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the 2009 Order"). (Note the Council are considering making a new On Street Parking Places Order ("the new Order"). If the new Order is made before the proposed variation Order, then the proposed variation Order will become an amendment to the new Order).
 - The effect of the proposed Order is to change the days that parking charges apply at the following existing on street charged parking places so that parking charges apply on 'all days (including Sundays)' instead of the current 'Monday to Saturday' that applies at present –
 - Barrack Road Service Road south west side, from 9 metres north west of Barrack Road north westwards for 22 metres (parking charge 90p per hour);
 - (b) Richardson Road north east side, from 28.5 metres north west of Queen Victoria Road north westwards for 259.5 metres (parking charge £1.30p per hour);
 - (c) **Richardson Road** north east side, from 29 metres north west of the access road to the University Halls of Residence north westwards for 267 metres (parking charge £1.20p per hour).
