

**CITY OF NEWCASTLE UPON TYNE
TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009
(CHIRTON WYND AREA VARIATION) ORDER 2018**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 (“the 2009 Order”). Note – the Council are considering making a new Consolidation Order (“the new Consolidation Order”). If the new Consolidation Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Consolidation Order.
2. The effect of the proposed Order is to **introduce a prohibition of waiting at any time restriction (double yellow lines)** on the following lengths of road –
 - (a) **Bothal Street** – west side, from Welbeck Road northwards for 31 metres;
 - (b) **Chirton Wynd** – both sides, from Welbeck Road northwards for 44 metres;
 - (c) **Welbeck Road** – north side, from Bothal Street/Allendale Road westwards for 65.4 metres.
3. Documents giving more detailed particulars of the Order (including draft Order, map and a statement of the Council’s reasons for proposing to make the Order), and the 2009 Order, may be inspected free of charge at –
 - (a) East End Customer Service Centre and Library, Hadrian Square, Byker, Newcastle upon Tyne, NE6 1AL between 10am and 6pm on Monday, 10am and 2pm on Thursday and 10am and 5pm on Friday);
 - (b) Customer Services, Central Library, Charles Avison Building, 33 New Bridge Street West, Newcastle upon Tyne, NE1 8AX between 10.00am and 4.30pm Monday to Friday;
 - (c) Newcastle Civic Centre, Barras Bridge, Newcastle upon Tyne, NE1 8QH between 9.00am and 4.30pm Monday to Friday.
