

**CITY OF NEWCASTLE UPON TYNE
(ON STREET PARKING PLACES) ORDER 2009
(CHESTER STREET AREA VARIATION) ORDER 2017**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 (“the 2009 Order”). Note – the Council are currently in the process of making a new 2017 Order. If the 2017 Order is made before the proposed Order, then the proposed Order will become an amendment to the 2017 Order.
2. The effect of the proposed Order is to combine the descriptions in the 2009 Order of the existing permit parking places with parking meters on Chester Street and Byron Street to provide one parking place as follows:-

Chester/Byron Street – east side, from 29 metres south of Gladstone Terrace (south) northwards for 208.8 metres.

This amendment will reflect the situation on the ground as there is no separation between the Chester Street and Byron Street parking places. No physical changes to the restrictions on Byron Street or Chester Street will be required.

(The parking places are currently described as Chester Street - east side, from a point opposite the north kerbline of Gladstone Place northwards for 174.8 metres, and Byron Street – east side, from 4.5 metres north of Gladstone Place (south) southwards for 38 metres).

The charge is 80p per hour payable between 8am and 6.30pm all days and the maximum period of stay is all day. Parking Zone OB1 permit holders are exempt from the charge.

3. Documents giving more detailed particulars of the Order (including the draft Order, map and a statement of the Council’s reasons for proposing to make the Order), and the 2009 Order may be viewed free of charge at –
 - (a) Customer Services, Central Library, Charles Avison Building, 33 New Bridge Street West, Newcastle upon Tyne, NE1 8AX between 10.00am and 4.30pm Monday to Friday,
 - (b) Newcastle Civic Centre, Barras Bridge, Newcastle upon Tyne, NE1 8QH between 9.00 am to 4.30 pm Monday to Friday.
