

**CITY OF NEWCASTLE UPON TYNE
TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009
(TAMWORTH ROAD AREA VARIATION) ORDER 2019**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 (“the 2009 Order”). Note – the Council are considering making a new Consolidation Order (“the new Consolidation Order”). If the new Consolidation Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Consolidation Order.
2. The effect of the proposed Order is to **introduce a prohibition of waiting at any time restriction (double yellow lines)** on the following lengths of road –
 - (a) **Croydon Road** – west side, from Wellesley Terrace northwards for 6.6 metres;
 - (b) **Longley Street** – north side, from Tamworth Road eastwards for 12 metres;
 - (c) **Tamworth Road** –
 - (i) east side, from Longley Street northwards for 10 metres;
 - (ii) west side, from 41.2 metres south of Longley Street southwards for 17.8 metres;
 - (d) **Wellesley Terrace** –
 - (i) south side, from Bishop’s Avenue westwards for 31.5 metres;
 - (ii) north side, from Croydon Road westwards for 14.4 metres.
3. Documents giving more detailed particulars of the Order (including draft Order, map and a statement of the Council’s reasons for proposing to make the Order), and the 2009 Order, may be inspected free of charge at –
 - (a) West End Customer Service Centre and Library, Condercum Road, Benwell, Newcastle upon Tyne, NE4 9JH (between 10am and 6pm on Monday, 10am and 2pm on Wednesday and 10am and 5pm on Friday - closed on Tuesday and Thursday);
 - (b) Customer Services, Central Library, Charles Avison Building, 33 New Bridge Street West, Newcastle upon Tyne, NE1 8AX between 10.00am and 4.30pm Monday to Friday;

- (c) Newcastle Civic Centre, Barras Bridge, Newcastle upon Tyne, NE1 8QH between 9.00am and 4.30pm Monday to Friday.
