

**CITY OF NEWCASTLE UPON TYNE  
(GREAT NORTH ROAD AREA)  
SPEED LIMIT ORDER 2019**

1. **NOTICE IS HEREBY GIVEN** that Newcastle City Council propose to make an Order under Sections 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended.
2. The effect of the proposed Order is to –
  - (a) introduce a 20mph speed limit on the following –
    - (i) **Church Road** – from Gosforth High Street to 20 metres east of Alwinton Terrace;
    - (ii) **High Street, Gosforth** – from 22 metres south of Elmfield Road to 61 metres south of Spital Terrace;
    - (iii) **Salters Road** – from High Street, Gosforth to 10 metres east of Hedley Street;
  - (b) introduce a 40mph speed limit on the following –
    - (i) **Great North Road** - from Claremont Road to 266 metres north of Forsyth Road (**Note** – the existing speed limit of 50mph on this length of road will be revoked);
    - (ii) **Great North Road** – from 68 metres north of Brunton Lane to the A1 interchange;
    - (iii) **Great North Road** (spur adjacent to Newcastle Racecourse) – between Rotary Way and the main carriageway of Great North Road (including overbridge)
  - Note** - All other lengths of **Great North Road** will become, or remain, subject to a 30mph speed limit due to the presence of a system of street lighting;
  - (c) revoke the 40mph speed limit on that length of **A189 Barrack Road/Ponteland Road/Grandstand Road** from Great North Road to 210 metres west of Great North Road. This length of road will become subject to a 30mph speed limit due to the presence of a system of street lighting.
  - (d) revoke existing speed limit Order relating to the length of road referred to in paragraph (a) (ii) above.
  - (e) revoke the existing 40mph speed limit on that length of Jesmond Dene Road from Great North Road to 93 metres south west of Ilford Road. This length of road will become subject to a 30mph speed limit due to the presence of a system of street lighting.
