## CITY OF NEWCASTLE UPON TYNE TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009 (WARKWORTH STREET AREA VARIATION) ORDER 2019

- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Order"). Note the Council are considering making a new Consolidation Order ("the new Consolidation Order"). If the new Consolidation Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Consolidation Order.
- 2. The effect of the proposed Order is to introduce a prohibition of waiting at any time restriction (double yellow lines) on the following lengths of road
  - (a) Back Loraine Terrace -
    - (i) both sides, from Warkworth Street westwards for 9 metres;
    - (ii) north side, from 6 metres east of Back Warkworth Street to 8 metres west of Back Warkworth Street;
  - (b) **Back Warkworth Street** both sides, from Back Loraine Terrace northwards for 8 metres;
  - (c) **Warkworth Street** west side, from 8 metres south of Back Loraine Terrace to 8 metres north of Back Loraine Terrace.
- 3. Documents giving more detailed particulars of the Order (including draft Order, map and a statement of the Council's reasons for proposing to make the Order), and the 2009 Order, may be inspected free of charge at

  - (c) Newcastle Civic Centre, Barras Bridge, Newcastle upon Tyne, NE1 8QH between 9am and 4.30pm Monday to Friday.
