- 2. 11.3 metres south of its junction with Mitford Drive,
- 3. 11.2 metres north of its junction with Chipchase Crescent (South),
- 4. 13.1 metres south of its junction with **Dilton Drive (North)**,
- 5. 49.1 metres north of its junction with **Dilton Drive (South)**
- 6. 17.1 metres south of its junction with **Dilton Drive (South).**
