Etal Way Area

(i) **Traffic Regulation (Consolidation) Order 2009 (Etal Way Area Variation) Order 2019**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 (“the 2009 Consolidation Order”). Note – the Council are considering making a new Consolidation Order (“the new Consolidation Order”). If the new Consolidation Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Consolidation Order.
2. The effect of the proposed Order is to **introduce a prohibition of waiting at any time restriction (double yellow lines)** on the following lengths of road –
 - (a) **Beaumaris Way (East)** – both sides, from Etal Way westwards for 16.3 metres;
 - (b) **Berrington Drive** – both sides, from Etal Lane southwards for 22.8 metres;
 - (c) **Etal Lane** –
 - (i) south side, from 30.1 metres west of Berrington Drive eastwards for 58 metres;
 - (ii) north side, from 28.5 metres west of Etal Way (West) eastwards for 55.3 metres;
 - (d) **Etal Way** –
 - (i) north side, from 29.5 metres north of Beaumaris Way (East) southwards for 40.7 metres;
 - (ii) east side, from 15.8 metres north of Beaumaris Way (East) southwards to Etal Lane;
 - (iii) west side, from 31.3 metres north of Etal Lane southwards to Etal Lane;
 - (e) **Etal Way (West)** – both sides, from Etal Lane northwards for 21.3 metres.

(ii) **Proposed Construction of Road Humps – Etal Way**

1. **NOTICE IS HEREBY GIVEN** in accordance with Section 90C of the Highways Act 1980 that the Council of the City of Newcastle upon Tyne in exercise of its powers under Section 90A of the Highways Act 1980 proposes to construct road humps complying with the Highways (Road Humps) Regulations 1999 in **Etal Way**.
2. The proposed nature, dimensions and locations of the road humps are as follows:-

Nature

(1) Speed Cushions (x2)

Locations (to the centre of the road humps)

Etal Way

- (a) 27.4 metres north of its junction with **Beaumaris Way (West)**
- (b) 21 metres north of its junction with **Meadow Rise**
- (c) 34.1 metres north of its junction with **Beaumaris Way (East)**

(2) Speed Cushions (x3)

Locations (to the centre of the road humps)

Etal Way

- (d). 38.8 metres north of its junction with **Haggerston Crescent**,
- (e). 31.5 metres north of its junction with **Shearwater Close**,
- (f). 31.7 metres east of its junction with **Swanton Close**,
- (g). 23.3 metres east of its junction with **Malthouse Way**,
- (h). 41.7 metres south of its junction with **Hickling Court**.

Buildouts (x2) will also be constructed at locations (a), (b), (c) and (e) above.

Dimensions

All of the speed cushions specified above will be 3.6 metres in length along the carriageway, will be 85mm in height and the ramp gradients will be 1 in 10.

The widths across the carriageway will be 1.7 metres per cushion in respect of items (a), (b), (c), (d) and (e) above, and will be 1.6 metres per cushion in respect of items (f), (g) and (h) above.
