WESTGATE ROAD AREA

(i) **Traffic Regulation (Consolidation) Order 2009 (Westgate Road Area Variation) Order 2019**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Consolidation Order"). Note – the Council is considering making a new Consolidation Order ("the new Order"). If the new Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Order.

2. The effect of the proposed Order is to –

(a) prohibit waiting at any time (double yellow lines) on the following lengths of road –

(i) **Back Northcote Street** – both sides, from Westgate Road northwards for 10 metres,

(ii) **Beaconsfield Street** –

(1) east side, from Westgate Road northwards for 19.5 metres,

(2) west side, from Westgate Road northwards for 28.6 metres,

(iii) **Westgate Road** – north side, from 23.8 metres east of Beaconsfield Street eastwards for 6.7 metres;

(b) amend lengths of existing no waiting at any time restrictions (double yellow lines) so that they extend as follows -

Westgate Road –

(1) north side, from 49.6 metres west of Beaconsfield Street to 7.7 metres east of Beaconsfield Street (currently extends from 10.8 metres west of Beaconsfield Street to 7.7 metres east of Beaconsfield Street),

(2) south side, from 40.5 metres west of Gloucester Road to 32.8 metres east of Gloucester Road (currently from 38.5 metres west of Gloucester Road to 18.3 metres east of Gloucester Road);

(c) revoke the existing no waiting at any time restriction (double yellow lines) on both sides of **Beaconsfield Street** from Westgate Road northwards for 12.1 metres;

(d) prohibit waiting between 8am to 9.15am and 4pm to 6pm Monday to Friday (single yellow lines) on the following lengths of road –

Westgate Road –

- (1) south side, from 38 metres west of Mill Lane eastwards for 28.8 metres,
 - (2) south side, from 7.5 metres east of Mill Lane eastwards for 93.3 metres,
 - (3) south side, from 9.9 metres east of Kingsley Terrace eastwards for 26.7 metres;
 - (4) south side, from 32.8 metres east of Gloucester Road to Elswick Road;
- (e) amend the length of an existing no waiting between 8am to 9.15am and 4pm to 6pm Monday to Friday restriction (single yellow lines) so that it extends as follows -

Westgate Road – north side, from 13 metres east of Bishops Avenue eastwards for 92.8 metres (currently extends from 33 metres west of Bishops Avenue westwards for 13.8 metres);

- (f) prohibit loading/unloading between 8am to 9.15am and 4pm to 6pm Monday to Friday on the following lengths of road –

Westgate Road –

- (1) north side, between Northcote Street and Corporation Street,
- (2) south side, from 32.8 metres east of Gloucester Road to Elswick Road.

(ii) Proposed Toucan Crossing – Westgate Road

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne, in exercise of its powers under Section 23(1) of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers, and after consultation with the Chief Officer of Police proposes to establish (install) a toucan crossing at the following location:-

Westgate Road – 11.2 metres east of its junction with Gloucester Road (length of restricted area along the carriageway to 21.5 metres, width across the carriageway to be full width).

2. The proposed toucan crossing is necessary to facilitate pedestrians and cyclists crossing on the above road.

Documents giving more detailed particulars of all of the proposals specified in this Notice (including draft Order, Notice, map and a statement of the Council's reasons for the proposals), and the 2009 Consolidation Order may be inspected free of charge at -

- (a) the West End Customer Service Centre and Library, Condercum Road, Benwell, Newcastle upon Tyne, NE4 9JH between 10am and 6pm on Monday, 10am and 2pm on Wednesday and 10am and 5pm on Friday (closed on Tuesday and Thursday),
- (b) Customer Services, Newcastle Central Library, Charles Avison Building, 33 New Bridge Street West, Newcastle upon Tyne, NE1 8AX between 10.00am and 4.30pm Monday to Friday, and
- (c) Newcastle Civic Centre, Barras Bridge, Newcastle upon Tyne, NE1 8QH between 9.00am and 4.30pm Monday to Friday.
