CITY OF NEWCASTLE UPON TYNE TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009 [2017] (WALKER ROAD AREA VARIATION) ORDER 2017

- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Order"). Note the Council is currently in the process of making a new 2017 Consolidation Order ("the 2017 Order"). If the 2017 Order is made before the proposed Order, then the proposed Order will become an amendment to the 2017 Order.
- 2. The effect of the proposed Order is to introduce a **prohibition of waiting at any time restriction** (double yellow lines) on the following lengths of road
 - (a) **Bakewell Terrace** both sides, from Walker Road southwards for 28 metres:
 - (b) **Evistones Gardens –** both sides, from Walker Road southwards for 30 metres;
 - (c) The Oval both sides, from Walker Road southwards for 26 metres;
 - (d) Walker Road -
 - (i) south side, from 22 metres east of Evistones Gardens westwards for 55 metres;
 - (ii) south side, from 13 metres east of The Oval westwards for 23 metres:
 - (iii) south side, from 9 metres east of Bakewell Terrace westwards for 29 metres.
- 3. Documents giving more detailed particulars of the Order (including draft Order, map and a statement of the Council's reasons for proposing to make the Order), and the 2009 Order, may be inspected free of charge at
