CITY OF NEWCASTLE UPON TYNE (ON STREET PARKING PLACES) ORDER 2009 (NUN STREET VARIATION) ORDER 2017

- NOTICE IS HEREBY GIVEN that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the 2009 Order"). (Note the Council are currently in the process of making a new 2017 On Street Parking Places Order ("the 2017 Order"). If the 2017 Order is made before the proposed Order, then the proposed Order will become an amendment to the 2017 Order).
- 2. The effects of the proposed Order are to -
 - (a) designate the following length of road as a parking place with waiting limited to 15 minutes (no return for 6 hours). The parking place will operate between 6am and 6.30pm all days
 - **Nun Street** north side, from 17 metres east of Clayton Street eastwards for 12 metres.
 - (b) revoke the existing parking place for loading/unloading by any vehicle between 6am and 6.30pm all days on the same length of road as specified in paragraph (a) above to accommodate the new limited waiting parking place.

(The existing parking place for taxis between 6.30pm and 6am all days on the same length of road will remain unchanged).
