

**CITY OF NEWCASTLE UPON TYNE
(ON STREET PARKING PLACES) ORDER 2009
(BIGG MARKET VARIATION) ORDER 2018**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 (“the On Street Order”). (Note – the Council are currently in the process of making a new On Street Parking Places Order (“the new Order”). If the new Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Order).
2. The effect of the proposed Order is to -
 - (a) to **revoke (remove)** the existing **shared use parking places** on the following lengths of the north side of **Bigg Market** which operate **between 8am-6.30pm all days as parking places for loading, and between 6.30pm-8am all days as parking places for taxis –**
 - (i) from 29 metres east of Grainger Street eastwards for 25 metres;
 - (ii) from 60 metres east of Grainger Street eastwards for 12 metres;
 - (b) to **revoke (remove)** the existing all days, all times **parking place for taxis** on the following length of the north side of **Bigg Market –**
 - (i) from 77 metres east of Grainger Street eastwards for 17.5 metres;
 - (c) to **revoke (remove)** the existing **parking place for the charging of Electric Vehicles** on the following length of the south side of **Bigg Market –**
 - (i) from 10.5 metres east of Pudding Chare eastwards for 11 metres;
 - (d) to **revoke (remove)** the existing 8am-6.30pm all days **parking places for loading only** on the following lengths of the south side of **Bigg Market –**
 - (i) south side, from 43 metres east of Grainger Street eastwards for 5 metres;
 - (ii) south side, from 64 metres east of Grainger Street eastwards for 12 metres;
 - (e) to **revoke (remove)** the existing **parking places with parking meters** on the following lengths of the south side of **Bigg Market –**
 - (i) from 19 metres east of Grainger Street eastwards for 15 metres;
 - (ii) from 48 metres east of Grainger Street eastwards for 16 metres;

- (f) **to designate** the following lengths of the south side of **Bigg Market** as **parking places for loading by goods vehicles only between the hours of 8.00am - 6.30pm all days -**
- (i) from 17 metres east of Grainger Street eastwards for 18 metres;
 - (ii) from 43 metres east of Grainger Street eastwards for 17 metres;
 - (iii) from 10.5 metres east of Pudding Chare eastwards for 15 metres.
3. Documents giving more detailed particulars of the proposals (including draft Order, map and a statement of the Council's reasons for proposing to make to the Order), and the On Street Order may be inspected free of charge at

 - (b) Newcastle Civic Centre, Barras Bridge, Newcastle upon Tyne, NE1 8QH between 9.00 am and 4.30 pm Monday to Friday.
