KINGSTON PARK ROAD / WINDSOR WAY AREA

(i) Traffic Regulation (Consolidation) Order 2009 (Kingston Park Road Area / Fawdon Walk Variation) Order 2019

- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the Consolidation Order"). Note the Council are considering making a new Consolidation Order. If the new Consolidation Order is made before the proposed Order, then the proposed Order will become an amendment to the new Consolidation Order.
- 2. The effect of the proposed Order is
 - (a) to introduce a no waiting at any time restriction (double yellow lines) on the following lengths of road -
 - A1 northbound off slip road (Kingston Park Road interchange)

 west side, from Kingston Park Road roundabout southwards for 32 metres;
 - A1 southbound on slip road (Kingston Park Road interchange)

 east side, from Kingston Park Road roundabout southwards for 20 metres;
 - (3) A1 / Kingston Park Road roundabout circulatory carriageway south east side, between Kingston Park Road and A1 southbound on slip road
 - (4) **Kingston Park Road** south side, from the A1 roundabout eastwards for 26 metres.
 - (b) to introduce a prohibition of driving of motor vehicles restriction on the following length of road –

Fawdon Walk - from Windsor Way eastwards for 285 metres.

(ii) **Proposed Pedestrian Crossings – Kingston Park Road and Windsor Way**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne, in exercise of its powers under Section 23(1) of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers, and after consultation with the Chief Officer of Police proposes to establish the following pedestrian crossings at the following locations –

Toucan Crossings (to facilitate pedestrians and cyclists crossing the roads) -

- (i) **Kingston Park Road** 16 metres east of its junction with Windsor Way;
- (ii) **Kingston Park Road** 16 metres west of its junction with Windsor Way;

- (iii) **Windsor Way** 17 metres south of Kingston Park Road;
- (iv) **Windsor Way** at its junction with Fawdon Walk (control area: from a point 15 metres south of its junction to a point 12 north of its junction).

(iii) **Proposed Construction of Road Humps – Windsor Way Area**

- 1. **NOTICE IS HEREBY GIVEN** in accordance with Section 90C of the Highways Act 1980 that the Council of the City of Newcastle upon Tyne in exercise of its powers under Section 90A of the Highways Act 1980 proposes to construct road humps complying with the Highways (Road Humps) Regulations 1999 in the Windsor Way Area.
- 2. Both of the road humps specified below will extend over the full width of the carriageway, be 85mm in height and the gradient of the ramps will be 1:20. The proposed nature, locations and lengths are as follows:-

Nature – Raised Tables

Locations -

- (i) **Windsor Way / Skelton Court** at the junction
- (ii) **Windsor Way** at its junction with Fawdon Walk

Lengths along the carriageway to be -

- Windsor Way from a point 11 metres south of the junction to a point 11 metres north of the junction and Skelton Court – from the junction to a point 12 metres east of the junction
- (ii) 11 metres.
