

**CITY OF NEWCASTLE UPON TYNE
(VARIOUS ROADS – OUTSIDE OF SCHOOLS)
SPEED LIMIT ORDER 2019**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Section 84 of Schedule 9 of the Road Traffic Regulation Act 1984, as amended.
2. The effect of the proposed Order is to introduce a 20 miles per hour speed limit on the roads or lengths of roads specified in the Schedule to this Notice.
3. Documents giving more detailed particulars of the Order (including a draft Order, map and a statement of the Council's reasons for proposing to make the Order) can be viewed free of charge at –

 - (c) West End Customer Service Centre and Library, Condercum Road, Benwell, Newcastle upon Tyne, NE4 9JH between 10am and 6pm on Monday, 10am and 2pm on Wednesday and 10am and 5pm on Friday - closed on Tuesday and Thursday;
 - (d) Customer Services, Central Library, Charles Avison Building, 33 New Bridge Street West, Newcastle upon Tyne, NE1 8AX between 10.00am and 4.30pm Monday to Friday; and
 - (e) Newcastle Civic Centre, Barras Bridge, Newcastle upon Tyne, NE1 8QH between 9.00 am to 4.30 pm Monday to Friday.
