

**CITY OF NEWCASTLE UPON TYNE**  
**TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009**  
**(STANNINGTON GROVE / STANNINGTON AVENUE AREA VARIATION) ORDER**  
**2019**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 (“the 2009 Order”). Note – the Council are considering making a new Consolidation Order (“the new Consolidation Order”). If the new Consolidation Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Consolidation Order.
2. The effect of the proposed Order is to **introduce a prohibition of waiting at any time restriction (double yellow lines)** on the following lengths of road –
  - (a) **Heaton Hall Road** – both sides, from Stannington Avenue/Wandsworth Road southwards for 13 metres,
  - (b) **Stannington Avenue** – both sides, from Stannington Avenue/Heaton Hall Road eastwards for 14.5 metres,
  - (c) **Stannington Grove** – both sides, from Stannington Avenue/Wandsworth Road northwards for 15 metres, and
  - (d) **Wandsworth Road** - both sides, from Stannington Grove/Stannington Avenue westwards for 13 metres.
3. Documents giving more detailed particulars of the Order (including draft Order, map and a statement of the Council’s reasons for proposing to make the Order), and the 2009 Order, may be inspected free of charge at –
  - (a) Customer Services, Newcastle Central Library, Charles Avison Building, 33 New Bridge Street West, Newcastle upon Tyne, NE1 8AX between 10.00am and 4.30pm Monday to Friday, and
  - (b) Newcastle Civic Centre, Barras Bridge, Newcastle upon Tyne, NE1 8QH between 9.00am and 4.30pm Monday to Friday.
