CITY OF NEWCASTLE UPON TYNE (ON STREET PARKING PLACES) ORDER 2009 [2017] (BURDON TERRACE VARIATION) ORDER 2017

- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the On Street Order"). (Note the Council are currently in the process of making a new 2017 On Street Parking Places Order ("the 2017 Order"). If the 2017 Order is made before the proposed Order, then the proposed Order will become an amendment to the 2017 Order).
- 2. The effect of the proposed Order is to -
 - (a) designate the following length of Burdon Terrace as a parking place for Disabled Badge Holders and Buses. The parking place will operate as follows – between 8.00am and 6.30pm Monday to Friday the parking place will be designated for Buses only, and between 6.30pm and 8.00am Monday to Friday and all day Saturday and Sunday the parking place will be designated for Disabled Badge Holders only -
 - (i) north side, from 15 metres west of Tankerville Terrace westwards for 14 metres;
 - (b) to relocate the existing parking place for Disabled Badge Holders on the north side of **Burdon Terrace** so that it extends from 29 metres west of Tankerville Terrace westwards for 12 metres (currently extends from 15 metres west of Tankerville Terrace westwards for 12 metres);
 - (c) to designate the following length of **Burdon Terrace** as a parking place with parking meters for use by motor cars, invalid carriages and motor cycles. The parking charge, payable between 8am and 6.30pm Monday to Saturday, will be 60p per hour and the maximum period of stay is 4 hours. Payment of the parking charge can be made at the ticket machine or by mobile telephone. Where the telephone payment service is used to pay a parking charge a transaction fee of 14p is also payable
 - (i) north side, from 42 metres west of Tankerville Terrace westwards for 136 metres;
 - (d) to revoke the existing parking places with parking meters on the following lengths of the north side of **Burdon Terrace**
 - (i) from 14 metres east of Abbotsford Terrace eastwards for 62 metres;
 - (ii) from 27 metres west of Tankerville Terrace westwards for 48 metres.
