CITY OF NEWCASTLE UPON TYNE TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009 [2017] (PRINCES ROAD AND GRENVILLE DRIVE, BRUNTON PARK ESTATE VARIATION) ORDER 2017

- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Order"). Note the Council are currently in the process of making a new 2017 Consolidation Order ("the 2017 Order"). If the 2017 Order is made before the proposed Order, then the proposed Order will become an amendment to the 2017 Order.
- 2. The effect of the proposed Order is to
 - (a) increase the length of existing no waiting at any time restriction (double yellow lines) on the north west side of Princes Road, Brunton Park Estate so that it extends from 30 metres north east of Polwarth Drive south westwards for 135 metres (restriction currently extends from 20 metres north east of Polwarth Drive south westwards for 125 metres);
 - (b) **introduce a prohibition of waiting at any time restriction** (double yellow lines) on the following lengths of road -
 - (i) **Grenville Drive, Brunton Park Estate** both sides, from Princes Road north westwards for 14.1 metres;
 - (ii) **Grenville Drive, Brunton Park Estate** south side, from 26.5 metres north west of Princes Road north westwards for 26.5 metres;
 - (iii) Princes Road, Brunton Park Estate north west side, from 14.6 metres north east of Grenville Drive south westwards for 27.4 metres.

The reason for the proposals is to remove indiscriminate and obstructive parking which is causing a potential road safety hazard and access problems particularly for larger vehicles.
