

CITY OF NEWCASTLE UPON TYNE

(i) (Allerdale Drive/Coniston Grove/Douglas Place) Speed Limit Order 2020

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended.
2. The effect of the proposed Order is to introduce a 20 miles per hour speed limit on the entire lengths of the following roads –

Allerdale Drive, Coniston Grove and Douglas Place.

(ii) Traffic Regulation (Consolidation) Order 2009 (Avison Street Area Variation) Order 2020

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 (“the 2009 Consolidation Order”).
2. The effect of the proposed Order is to -

- (a) introduce a no waiting at any time restriction (double yellow lines) on the following –

Douglas Place –

- (i) west and north sides, from Douglas Terrace northwards and eastwards for 57 metres along the kerblines,
 - (ii) east side, from Douglas Terrace northwards for 9.5 metres,
 - (iii) east, south and north sides, from 20.5 metres north of Douglas Terrace northwards for 16 metres including the turning area,
- (b) increase in length an existing no waiting at any time restriction (double yellow lines) on the east side of Avison Street so that it extends as follows –

Avison Street – east side, from Avison Place southwards for 56 metres (currently extends from Avison Place southwards for 8 metres).

- (c) increase in length an existing no waiting at any time restriction (double yellow lines) on the north side of Douglas Terrace so that it extends as follows –

Douglas Terrace – north side, from Avison Street eastwards for 70 metres (currently extends from Avison Street eastwards for 33 metres).

- (d) reduce in length an existing no waiting 8am to 6.30pm Monday to Friday restriction (single yellow line) on the east side of Avison Street so that it extends as follows –

Avison Street – east side, from 23 metres north of Douglas Terrace northwards for 27.5 metres (currently extends from 23 metres north of Douglas Terrace northwards for 48 metres).
