CITY OF NEWCASTLE UPON TYNE TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009 (ROUNDHILL AVENUE AREA VARIATION) ORDER 2020

- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Consolidation Order"). Note the Council are considering making a new Consolidation Order ("the new Consolidation Order"). If the new Consolidation Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Consolidation Order.
- 2. The effect of the proposed Order is to introduce a no waiting at any time restriction (double yellow lines) on the following lengths of road
 - (a) **Rothay Place** east side, from Roundhill Avenue southwards for 58.1 metres:
 - (b) Roundhill Avenue
 - (i) west side, from 8.8 metres south of Walling Road northwards for 21.3 metres,
 - (ii) west side, from 37.5 metres north of Walling Road north westwards for 24.7 metres,
 - (iii) south side, from Rothay Place eastwards for 149.8 metres,
 - (iv) north side, from 12.3 metres west of the northern leg of Roundhill Avenue eastwards for 25 metres.
 - (c) **Roundhill Avenue (northern leg)** both sides, from Roundhill Avenue northwards for 13.4 metres,
 - (d) Walling Road -
 - (i) north side, from Rothay Place eastwards for 16.1 metres,
 - (ii) north side, from Roundhill Avenue westwards for 34.9 metres,
 - (iii) south side, from Rothay Place eastwards for 95.7 metres,
 - (iv) south side, from Roundhill Avenue westwards for 9.9 metres,
 - (v) south side, from 34.9 metres west of Roundhill Avenue westwards for 61.5 metres.
