

## CITY OF NEWCASTLE UPON TYNE

### MAIN ROAD (B6918) AND STATION ROAD

#### (i) **Traffic Regulation (Consolidation) Order 2009 (Main Road (B6918) and Station Road Variation) Order 2020**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Consolidation Order").
2. The effect of the proposed Order is to increase a length of existing no waiting at any time restrictions (double yellow lines) on both sides of Station Road and on the south side of Main Road so that they extend as follows –
  - (a) **Main Road (B6918)** – south side, from 41 metres east of Station Road to 81 metres west of Station Road (currently extends from 22 metres north west of Station Road to 22 metres north east of Station Road);
  - (b) **Station Road** – both sides, from Main Road (B6918) southwards for 54 metres (currently extends from Main Road (B6918) eastwards for 18 metres).

#### (ii) **(On Street Parking Places) Order 2009 (Main Road (B6918) Variation) Order 2020**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the 2009 On Street Order").
2. The effect of the proposed Order is to -
  - (a) remove the following section of existing permit holders parking place (operative when traffic signs are displayed) on Main Road (B6918) –

**Main Road (B6918)** – south side, from 26 metres north west of Station Road north westwards for 40 metres. This will be replaced by proposed double yellow lines.
  - (b) reduce in length an existing permit holders parking place on the south side of Main Road (B6918) so that it extends as follows –

**Main Road (B6918)** – south side, from 41 metres east of Station Road eastwards for 70 metres (currently extends from 30 metres south east of Station Road south eastwards for 67 metres). This will be replaced by proposed double yellow lines.
