QUAYSIDE - LOWER STEENBERG'S YARD AREA

- (i) (Quayside Lower Steenberg's Yard Area) Speed Limit Order 2020
- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Section 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.
- 2. The effect of the proposed Order is to introduce a 20mph speed limit zone comprising the following lengths of road -
 - (i) **Back Maling Street** from Quayside northwards for the extents of the adopted highway,
 - Quayside from northernmost junction with St Lawrence Road northwards and westwards up to and including the turning area west of Horatio Street; and
 - (iii) Unnamed Link Road, Toffee Factory entire length.

Note – the length of Back Maling Street from Ford Street southwards for the extents of the adopted highway will remain as a 20mph speed limit.

- (ii) Traffic Regulation (Consolidation) Order 2009 (Quayside Lower Steenberg's Yard Area Variation) Order 2020
- NOTICE IS HEREBY GIVEN that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the Consolidation Order"). Note the Council are considering making a new Consolidation Order. If the new Consolidation Order is made before the proposed Order, then the proposed Order will become an amendment to the new Consolidation Order.
- The effect of the proposed Order is to remove from the Consolidation Order reference to the cycle lanes on the following lengths of the north side of Quayside –
 - (a) from 17 metres west of the western junction of St Lawrence Road/Quayside westwards for 104 metres; and
 - (b) from 20 metres east of the western junction of St Lawrence Road/Quayside to 21 metres west of its eastern junction of St Lawrence Road/Quayside.

Note - this is an administrative exercise only. The cycle lanes on the ground will not be affected and will remain in force.

(iii) Proposed Construction of Road Humps – Quayside - Lower Steenberg's Yard Area

- NOTICE IS HEREBY GIVEN in accordance with Section 90C of the Highways Act 1980 that the Council of the City of Newcastle upon Tyne in exercise of its powers under Section 90A of the Highways Act 1980 proposes to construct road humps complying with the Highways (Road Humps) Regulations 1999 in Quayside.
- 2. The proposed nature, dimensions and locations of the road humps are as follows:-

Nature - Speed Cushions

Locations -

- (a) **Quayside** from a point 190 metres east of its junction with Horatio Street;
- (b) Quayside from a point 243 metres east of its junction with Horatio Street;
- (c) **Quayside** from 65 metres east of its junction with Back Maling Street.

Dimensions

All of the speed cushions specified above will have a length along the carriageway of 3.6 metres, a width across the carriageway of 1.7 metres, be 85mm in height, have ramp gradients of 1 in 10 and side tapers of 1 in 6.
