## CITY OF NEWCASTLE UPON TYNE TRAFFIC REGULATION (CONSOLIDATION) ORDER 2009 (ARMSTRONG ROAD AREA VARIATION) ORDER 2021

- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Consolidation Order"). Note the Council are considering making a new Consolidation Order ("the new Consolidation Order"). If the new Consolidation Order is made before the proposed Variation Order, then the proposed Variation Order will become an amendment to the new Consolidation Order.
- 2. The effect of the proposed Order is to introduce no waiting at any time restrictions (double yellow lines) on the following lengths of road
  - (a) Armstrong Road -
    - (i) north side, from Walwick Fell eastwards for 78 metres,
    - (ii) north side, from 12 metres west of Wayside to 20 metres east of Milford Road,
    - (iii) south side, from Featherwood Avenue eastwards for 21 metres,
    - (iv) south side, from 18 metres west of Chester Pike to 27 metres east of Chester Pike,
  - (b) **Chester Pike** both sides, from Armstrong Road southwards for 12 metres,
  - (c) **Delaval Road** both sides, from Armstrong Road northwards for 17 metres.
  - (d) **Featherwood Avenue** both sides, from Armstrong Road southwards for 17 metres,
  - (e) **Milford Road** both sides, from Armstrong Road northwards for 17 metres.
  - (f) Walwick Fell east side, from Armstrong Road northwards for 10 metres, and
  - (g) **Wayside** both sides, from Armstrong Road northwards for 15 metres.
