

CITY OF NEWCASTLE UPON TYNE

RIDLEY PLACE AREA

(i) **Traffic Regulation (Consolidation) Order 2009 (Ridley Place Variation) Order 2021**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Consolidation Order"). Note – the Council are considering making a new Consolidation Order ("the new Consolidation Order"). If the new Consolidation Order is made before the proposed Variation Order, then the proposed Variation Order will become a variation to the new Consolidation Order.

2. The effect of the proposed Order is to -

- (1) introduce a **prohibition of loading/unloading at any time restriction** on the following lengths of road –

Ridley Place –

- (i) north side, from John Dobson Street westwards for 12 metres,
 - (ii) north side, from 90 metres west of John Dobson Street westwards for 12 metres,
 - (iii) south side, from John Dobson Street westwards for 18 metres,
 - (iv) south side, from 90 metres west of John Dobson Street westwards for 12 metres,
- (2) **amend** the point of **the prohibition of driving restriction** on **Ridley Place** so that it is between 12.5 metres east of Northumberland Street and 102 metres west of John Dobson Street (currently at a point 12.5 metres east of Northumberland Street),
- (3) **revoke the existing prohibition of loading/unloading at any time restriction** on both sides of **Ridley Place** from 12.5 metres east of Northumberland Street eastwards for 10 metres.

(ii) **(On Street Parking Places) Order 2009 (Ridley Place Variation) Order 2021**

1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the 2009 On Street Order"). Note – the Council are considering making a new On Street Order. If the new On Street Order is made before the proposed Order, then the proposed Variation Order will become a variation to the new On Street Order.

2. The effect of the proposed Order is to –

- (1) designate the following length of road as a **Parking Place for Disabled Badge Holders** which will operate all days and all times –

Ridley Place – south side, from 35 metres west of John Dobson Street westwards for 33 metres;

- (2) designate the following lengths of road as **Parking Places for Loading by Any Vehicle** which will operate **all days and all times** with a **maximum stay of 1 hour** and **return prohibited within 2 hours** –

(a) **Ridley Place -**

(i) north side, from 78 metres west of John Dobson Street westwards for 12 metres;

(ii) south side, from 78 metres west of John Dobson Street westwards for 12 metres;

(b) **Vine Lane** – west side, from 9 metres north of Ridley Place northwards for 12 metres;

- (3) **revoke** the following existing parking places -

(a) **Parking Places for Disabled Badge Holders on Ridley Place –**

(i) south side, from 95 metres west of John Dobson Street westwards for 13 metres;

(ii) north side, from 66 metres west of John Dobson Street westwards for 26.5 metres.

(b) **Parking Places for Loading (Goods Vehicles only) on Ridley Place -**

(i) north side, from 92.5 metres west of John Dobson Street westwards for 12 metres;

(ii) south side, from 93.5 metres west of John Dobson Street westwards for 12 metres.

(c) **Parking Places with Parking Meters on Ridley Place -**

(i) north side, from 24.5 metres west of John Dobson Street westwards for 41.5 metres;

(ii) south side, from 27.5 metres west of John Dobson Street westwards for 66 metres..
