CITY OF NEWCASTLE UPON TYNE (ON STREET PARKING PLACES) ORDER 2009 (WELDON CRESCENT AREA VARIATION) ORDER 2021

- NOTICE IS HEREBY GIVEN that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the 2009 Order"). Note the Council are considering making a new On Street Order. If the new On Street Order is made before the proposed Order, then the proposed Order will become an amendment to the new On Street Order.
- 2. The effect of the proposed Order is to designate the following roads/lengths of road as a parking place zone for permit holders between the hours of 11am 12 noon and 3pm 4pm Monday to Friday -

Weldon Crescent Area Zone consisting of the following lengths of road –

Duxfield Road - full length

Goswick Avenue - full length

Harlow Place - full length

Holystone Crescent - between Newton Road and Goswick Avenue

Lynmouth Place - full length

Weldon Crescent - between Newton Road and Goswick Avenue.

The parking place zone will be added to the 2009 Order and therefore the provisions and conditions of that Order will apply to it.

<u>NOTE</u>: Resident parking permits will be available for each eligible property (a maximum of 2 per property) which will exempt permit holders from the restriction. A visitor parking permit may also be issued to eligible residential properties (a maximum of one per property). Permits may also be available (if they would cause no unreasonable detriment to resident parking) for any property occupied by a business or charity (maximum numbers apply). Permits will be issued for Parking Zone H7. Details of permit charges/issue/renewal, conditions of use, discounts and types of permit are contained in the 2009 Order.

Eligible Properties: Duxfield Road – Nos. 1 to 23 odds & Nos. 2 to 24 even, **Goswick** Avenue – Nos. 1 to 25 odds & Nos. 2 to 30 even, **Harlow** Place – Nos. 1 to 13 odds & Nos. 2 to 14 even, **Holystone** Crescent – Nos. 99 to 167 odds & Nos. 102 to 192 even, **Lynmouth** Place – Nos. 1 to 13 odds & Nos. 2 to 14 even and **Weldon** Crescent – Nos. 85 to 143 odds & Nos. 76 to 134 even.
