- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Order").
- 2. The effect of the proposed Order is to -
 - (a) introduce a prohibition of waiting at any time restriction (double yellow lines) on the following lengths of road
 - (1) **Chalfont Road –** both sides, from Lancefield Avenue northwards for 10.7 metres
 - (2) Lancefield Avenue
 - (i) south side, from 3.2 metres south west of Chalfont Road eastwards for 14.6 metres.
 - (ii) north side, from 8.4 metres south west of Chalfont Road eastwards for 19.8 metres,
 - (b) introduce a prohibition of loading/unloading at any time restriction on the following lengths of road
 - (1) **Chalfont Road –** both sides, from Lancefield Avenue northwards for 10.7 metres.
 - (2) Lancefield Avenue -
 - (i) south east side, from 11.4 metres north east of Chalfont Road southwards for 55.4 metres,
 - (ii) north side, from 8.4 metres south west of Chalfont Road eastwards for 19.8 metres,
 - (iii) east side, from 23.1 metres north of Readhead Drive southwards direction for 44.9 metres,
 - (3) **Readhead Drive** both sides, from Lancefield Avenue eastwards for 11.9 metres.
