- 1. **NOTICE IS HEREBY GIVEN** that the Council of the City of Newcastle upon Tyne propose to make an Order ("On Street Variation") under Sections 32, 35, 45, 46, 49, 53, 63 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne (On Street Parking Places) Order 2009 ("the 2009 On Street Order"), and an Order ("Consolidation Variation") under Sections 1, 2, 4, 29 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 which amends the City of Newcastle upon Tyne Traffic Regulation (Consolidation) Order 2009 ("the 2009 Consolidation Order").
- 2. The effect of the proposed On Street Variation Order is as follows -
 - (a) to designate the following length of road as a parking place with waiting limited to a maximum of 30 minutes with no return within 6 hours. The parking place will operate between 8am and 6.30pm Monday to Saturday

Station Road – south side, from 8 metres east of Sandringham Road eastwards for 27 metres;

(b) to designate the following length of road as a parking place with waiting limited to a maximum of 4 hours with no return within 6 hours. The parking place will operate between 8am and 6.30pm Monday to Saturday –

Sandringham Road – east side, from 12 metres south of Station Road southwards for 18 metres.

- 3. The effect of the proposed Consolidation Variation Order is as follows -
 - (a) in order to accommodate the parking place specified in paragraph 2(a) above, the existing no waiting at any time restriction at the same location will be removed. Note all other lengths of existing no waiting at any time restriction on Station Road between Haddricks Mill Road and Church Avenue will remain unchanged.
- 4.
