#### **1.0 INTRODUCTION**

- 1.1 In accordance with Regulation 15(1)(b) of The Neighbourhood Planning (General) Regulations 2012, this Statement has been prepared to accompany the Submission Draft of the Dinnington Parish Neighbourhood Plan (hereinafter also referred to as the 'NP', 'Neighbourhood Plan' or 'Plan').
- 1.2 15(2) of the Regulations sets out that a Consultation Statement must -
  - 1) Contain details of the persons and bodies who were consulted about the proposed neighbourhood development plan;
  - 2) Explain how they were consulted;
  - 3) Summarise the main issues and concerns raised by the persons consulted;
  - 4) Describe how these issues and concerns have been considered and, where relevant, addressed in the proposed neighbourhood development plan.
- 1.3 In order to meet these requirements, this Statement is set out as follows -
  - Background to the Neighbourhood Plan;
  - Preparation of the Neighbourhood Plan, with chronological account of the key stages of public consultation from commencement up to the Pre-Submission stage, including who was consulted, what measures and methods were used (with examples/screenshots to help illustrate), the outcomes of consultation and how they were addressed in the development and drafting of the NP;
  - Conclusion and appendices.

#### 2.0 BACKGROUND TO THE NEIGHBOURHOOD PLAN

- 2.1 Prior to embarking on a Neighbourhood Plan, Dinnington Parish Council has had a long history working with and for the local community to maintain the character of the village and surrounding areas. Its established aims are to improve village facilities, encourage and support community events and activities, to improve the environment of the village and generally represent its interests<sup>1</sup>.
- 2.2 Against this background, the Parish Council expressed a very early interest in developing a Neighbourhood Plan 'to ensure that due provision is made for the environment in which the village is situated. It will also enable all the residents who live, work and play here to be fully involved in consideration of future development projects which can impact on their lives'<sup>2</sup>.




Figure 1 – Stro	nline motto	for the Ne	eighbourhood Plan

- 2.3 From the outset, this signalled the Parish Council's clear desire for the community to be empowered and engaged in the future of their local area, in turn setting a strong and positive springboard for the preparation of the Neighbourhood Plan. This was enshrined in early publicity about the Plan in the chosen strapline 'Your Village. Its Future. In Your Hands' (see Figure 1 overleaf).

#### Designation of Dinnington Parish as a Neighbourhood Area

- 2.4 This proactive approach led to the Parish having the distinction of being the first within Newcastle City Council's administrative area to apply for Neighbourhood Area status back in July 2013. The application was published within Dinnington Parish and via Newcastle City Council's website and letters were sent to local residents and statutory bodies. The consultation period ran from 1<sup>st</sup> August to 13<sup>th</sup> September 2013.
- 2.5 In total, six representations were made to the application, none of which raised any substantive or material objections. The representations were summarised as follows<sup>3</sup> -

Consultation Responses	Summary of comments
Northumberland County Council	No comments. Would be please to receive information about the neighbourhood plan as it progresses
Brunswick Parish Council	Object if boundary encroached on the Brunswick Parish Council boundary. The designated Dinnington Neighbourhood Plan area follows the Dinnington Parish Boundary does not encroach on the Brunswick Parish Boundary
Homes & Community Agency	Support the proposal but have no specific comments to make at this stage of the consultation process.
Northumbrian Water	No issues to raise with the designation of a Neighbourhood Area. But encourage engagement with NWL throughout the plan making process
The Coal Authority	No comments to make on the designation of the Neighbourhood Plan Area. Have provided comments to consider within the preparation of a neighbourhood plan
Newcastle International Airport	Requested the removal of the airports operational land. Discussions have been held between the Parish Council and the Airport. It was agreed between both parties that the proposed Neighbourhood Area boundary would remain the same as the Parish. However, the 'Airport Operational Area' should be clearly labelled to make people aware of this. I have attached the agreed plan.

- 2.6 Following the application and consultation period, Dinnington Parish was formally designated a Neighbourhood Area in December 2013.
- 2.7 The Neighbourhood Plan explains in more detail about development pressures which were emerging at this early stage, which served as a major impetus not only to the development of the Plan, but also to its ultimate focus and scope (see NP paragraphs 1.11-1.13).
- 2.8 In tandem with securing the Neighbourhood Area designation, a small Steering Group was formed to manage the work of preparing the Neighbourhood Plan. This was made up of Parish Councillors and members of the local community, reporting back to the formal Parish Council meetings.

#### **3.0 PREPARATION OF THE NEIGHBOURHOOD PLAN**

#### Stage 1 'broad-brush' consultation (2014)

- 3.1 Having got the essentials in place in 2013, the Steering Group began preparations for a first round of community consultation in 2014.
- 3.2 Advance publicity for this took place via the 'Dinnington Parish Newsletter', issued in Spring of 2014 (see extract at Figure 2 below). This is a biannual newsletter, distributed to all addresses in the Parish and containing news about the activities of the Parish Council as well as local community news. From the Spring 2014 edition (Issue 19) onwards, it included a regular feature to update progress on the Neighbourhood Plan. Copies of newsletters were also available to view on the Parish Council's website. They can be accessed via the website's Document Library<sup>4</sup> page at <a href="http://www.spanglefish.com/dinnington/library.asp">http://www.spanglefish.com/dinnington/library.asp</a>
- 3.3 Around about this time, a dedicated 'Neighbourhood Plan' page was also added to the Parish Council's website<sup>5</sup> which contained information and regular updates about the Plan.

- 3.4 This early consultation stage was designed to be a broad-brush initial information gathering exercise. Rather than seeking detailed answers to specific questions, it sought to understand people's likes and dislikes and their views and comments on basic themes.




Figure 3 – Geographical distribution of attendees of Stage 1 Drop-In Session from across the Parish and beyond (main map) and within the village itself (inset map)<sup>6</sup>

- 3.5 The consultation ran over the summer (June/July) of 2014 and consisted of the following 4 elements –

a) **Information/publicity leaflet, including box for making comments** – this was mailed out to all addresses in the Parish. It set out introductory information about the NP and advance publicity about the public drop-in session explained further in b) below. The leaflet also included provision to make comments, together with details of where to post them, plus contact details for the NP Steering Group members. The opportunity to make comments was to cater for those who may have been unable to attend the drop-in session, but wanted to make their views known.

b) **Drop-in Session** – this was held in the Village Hall from 10am till 6pm on Saturday 14<sup>th</sup> June 2014. The Chairman and members of the Steering Group were on hand to talk to attendees and listen to their comments and help gauge what issues they would like to see tackled in the NP. Feedback and survey forms were made available to gather written comments (see c and d), along with display boards explaining all about the NP and the consultation process (see para 3.8). Finally, attendance sheets were also kept so that there was a clear record of how many came along to the session and from which parts of the village (see mapped results of this at Figure 3 overleaf).

c) **Feedback form** – this asked for respondents to jot down what they considered to be the main issues facing the Parish, split into 3 parts –

- Issues which affect the respondent
- Issues which affect where the respondent lives
- Issues which affect the wider community

d) **Theme-based survey form** – this asked for respondents to identify what they considered to be the key issues in Dinnington Parish under 5 broad subjects –

- Transport
- Housing
- Education
- Health
- Environment

Finally, the survey form also asked respondents to identify the most favourite and least favourite things about living or working in the Parish.

3.6 Copies of the publicity/comments leaflet, the feedback form and the theme based survey form are included in Appendix 1a, 1b and 1c respectively at the end of this Statement.

3.7 Of the 4 options for providing feedback at Stage 1, the table below provides a snapshot of the number of responses and attendees.

- 3.8 As part of the Stage 1 consultation exercise, the Steering Group also provided explanatory and supporting information to let people know
  - What an NP is and what it can do (in broad terms and in terms of Dinnington Parish)
  - What the consultation involves and why it is being undertaken see Figure 4 overleaf, which helps highlight the Parish Council's commitment from the earliest stages to engaging widely and effectively with the community

3.9 As well as the completion of feedback and survey forms, other techniques for collecting feedback at the drop-in event were used. These included allowing people to record comments on post-it notes and using coloured sticky dots to identify the potential topics the NP could cover (see Figure 5 overleaf).

- 3.10 Whilst the Parish Council were very thorough to carefully record all the feedback from the Stage 1 consultation, a detailed analysis of it did not take place until 2016, coinciding with preparations for a second, more focused round of community consultation.
- 3.11 The main reason for this hiatus was the level of local controversy at the time upon proposals in the City Council's Core Strategy to release two large areas of Green Belt at the edges of the village for housing<sup>7</sup>. This naturally took centre stage of the Parish Council's time, effort and attention. Also, as explained in the NP (para 1.17), the decision to put the Plan on hold 'sought to avoid the possibility of carrying out abortive work before the Core Strategy had been completed and a final decision on the housing proposals had been reached'.
- 3.12 Following the Examination of the Core Strategy, the Inspector's Report was published in February 2015, which found the proposed Green Belt land releases to be sound. The housing allocations in Dinnington were therefore retained and the Core Strategy was adopted the following month.

3.13 Upon this outcome, the Steering Group were keen to get the NP back on track from a fresh base against the backdrop of the Core Strategy. Grant-aided professional support was obtained which led to a stock-take of work already undertaken, the delivery of dedicated workshop sessions<sup>8</sup>, a comprehensive review and analysis of Stage 1 consultation feedback and a focused action plan of further work to be done. The most pressing task moving forward was to re-launch the Neighbourhood Plan by re-engaging afresh with the community. Details of this are set out under 'Stage 2 consultation' from paragraph 3.19 below.

#### Outcomes from Stage 1 consultation

- 3.14 From the miscellany of feedback sought at Stage 1, a very broad and diverse set of issues emerged. This was a reflection of the consultation being characterised by 'big picture' open questions and free text, allowing a wide scope of potential comments. A key task was therefore to sift through, group and rank the feedback in order to identify the most common themes and issues. This also included filtering out a large contingent of non-planning issues which lay outside the legitimate scope of the NP.
- 3.15 Following this exercise, the following key issues emerged as consistent and strong themes for the community of Dinnington -
  - 1) Safeguard essential village character, scale and attractiveness
  - 2) Protect rural setting of village and access to it (walking/cycling)
  - 3) Protect open spaces, green environment and wildlife
  - 4) Maintain village as a safe environment
  - 5) Maintain/enhance local and accessible facilities and services
  - 6) Ensure infrastructure caters for new development
  - 7) Ensure housing meets local needs and is well designed
- 3.16 In respect of the last of these (Issue 7), it should be noted that this was raised as an issue before the planning applications had been made (which were subsequently granted) for the new housing sites at the edges of the village (see footnote 7). By the time of the second stage of consultation, this had rendered the issue overtaken by events, especially given Dinnington's Green Belt setting and the lack of scope for further new housing in the village beyond these new sites. Similarly, issue 4 was raised primarily in the context of new development leading to increasing traffic, together with increased noise and pollution. Again, this was nullified in the light of the housing permissions which were subsequently granted.
- 3.17 From the remaining list of five key issues (1, 2, 3, 5 and 6), three broad topic headings naturally emerged into which the issues could be placed. These in turn provided definitive building blocks for the content of the NP, as set out in the table overleaf.

3.18 It was abundantly clear from the various comments made at Stage 1 what the community's aspirations were for each of the 3 broad topic headings. Common to all of them was a strong desire to 'protect' and 'enhance' each of the identified issues. This then provided the context for arriving at a draft objective for each broad heading, together with an overarching Vision for the NP as a whole, which could be fed back to the community as part of the Stage 2 Consultation (details below).

#### Stage 2 'focussed questionnaire' consultation (late 2017/early 2018)

- 3.19 The overriding priorities for the Stage 2 consultation were
  - a) To re-engage with the community to re-launch the NP after the hiatus since Stage 1 and against the backdrop of the new housing proposals which had been approved at the edges of the village
  - b) To share and seek feedback/endorsement of the draft Vision and Topic Objectives which had captured the broad key messages from the Stage 1 consultation
  - c) To gather more targeted, higher resolution feedback, focussed around options for implementation of the Topic Objectives
  - d) To draft a questionnaire to facilitate b) and c) in such a way as to ensure results were able to be collated and analysed efficiently and effectively
- 3.20 In addition, the consultation sought to implement best practice in terms of the methodology of the consultation exercise, reflecting training on the subject which had earlier been delivered to the Steering Group as part of professional support on the NP (see footnote 8). This included ensuring the City Council were actively involved and on board with the consultation process and broad direction of travel of the NP.
- 3.21 The following bullet points summarise the key features of the Stage 2 consultation
  - The engagement and consultation took place over the period from  $\rm 27^{th}$  November 2017 to  $\rm 20^{th}$  January 2018

- It centred around an 8 page topic-focussed questionnaire, consisting of a total of 22 questions, split into the following sections
  - A) A Shared Vision for the Future of Dinnington
  - B) Topic 1 Village Character & Rural Setting
  - C) Topic 2 Green Environment
  - D) Topic 3 Community Infrastructure
  - E) Further Comments
  - F) Demographic Details

Section A) and sections B) to D) included the NP's draft vision and draft topic objectives respectively.

- A paper copy of the questionnaire was delivered to every address in the Parish as an enclosure with the Autumn/Winter 2017 edition of the Parish Council's newsletter. As well as this, the questionnaire was made available to complete online via 'SurveyMonkey' software from a link on the Parish Council's website. This made it subsequently easier to collate, sort and analyse the responses. A full copy of the questionnaire is included at Appendix 2 at the end of this Statement
- A public drop-in event was held in the Village Hall from 10am to 4pm on Saturday 9<sup>th</sup> December 2017. Members of the NP Steering Group were on hand to answer questions about the NP and help with the questionnaire, copies of which were available at the event.
- The consultation exercise was widely promoted via the Parish Council's Newsletter, the Parish Council website and by posters. A dedicated NP email address was also set up for any enquiries (in addition to the contact details of the Parish Clerk). Examples of the publicity are at Figure 6 below.
- Additionally, a further targeted publicity 'push' took place during the consultation period, consisting of Steering Group members visiting the church, the church coffee morning, the pantomime and the Women's Institute and drawing attention to the questionnaire.

#### Outcomes from Stage 2 consultation

3.22 Following the consultation exercise, a total of 127 completed questionnaires had been received from across the Parish (see Figure 7 below), as reported in the Parish newsletter for Spring/Summer 2018 (see Figure 8 below). A further 18 people attended the drop-in event held as part of the consultation on 9<sup>th</sup> December 2017.

- 3.23 The use of the SurveyMonkey system allowed for the questionnaire results to be systematically collated and analysed and also allowed statistical outputs to be quickly and accurately produced and presented in bar charts and pie charts. 'Free text' comments however needed to be manually grouped, quantified and ranked.
- 3.24 Statistically, the headline outputs from the questionnaire were that the overwhelming majority of respondents supported the draft Vision and 3 Topic Objectives, as indicated in the table overleaf. This provided a very clear mandate for the intended subject matter of the NP, as neatly summed up in one of the comments received: *'I think that the neighbourhood plan accurately corresponds with my own view of the future of Dinnington'.*

(Note that minor wording changes subsequently took place to the draft Vision and Topic Objectives in order to ensure that they were up to date and reflective of the final content and nomenclature used in the Pre-Submission NP)

- 3.25 In terms of comments and suggestions received in response to 'free text' questions in the Stage 2 questionnaire, these were initially collated by the Steering Group and quantified by frequency of comments made. As a large number of the comments still included non-planning issues, a further filtering out/consolidating exercise was necessary. A copy of the output from this is included at Appendix 3 of this Statement.
- 3.26 The main messages to emerge from the filtered comments were clearly evidenced in the frequency they were raised and the fact that they were repeated across the subject matter covered in the questionnaire. At the simplest level, the core messages boiled down to two tangible foci for the NP firstly the valued rural setting of Dinnington village and, secondly, the valued attributes of Dinnington village.
- 3.27 These in turn became the two substantive subject chapters of the Pre-Submission Plan. For the reasons explained in paragraph 1.24 and 1.25 of the Pre-Submission Plan, the first of these chapters took the form of a 'narrative' (ie not including a policy). However the second chapter includes two policies one dealing with the village's Local Green Spaces and the other dealing with the village's valued assets. The candidates for these were each identified via a combination of suggestions nominated in community feedback and the input of the NP Steering Group.
- 3.28 The approach to both chapters was developed in close liaison with the City Council in order to ensure it was endorsed and supported and in conformity with strategic local policy. The Basic Conditions Statement, prepared alongside this Consultation Statement, sets out how the NP fulfils this, and each of the other Basic Conditions.
- 3.29 Finally, the community were kept informed as the NP was developing, and up until it was finally drafted, via regular updates in the Dinnington Parish newsletter (see examples in Figure 9 overleaf). Regular updates were similarly made to the Parish Council's 'Neighbourhood Plan' webpage.

Issue 34: Apr 2022	Neighbourhood Plan During the year we finalised our Draft Neighbourhood Plan and Newcastle City Council completed the appropriate health-checking of the document, along with their own screening assessment. This has allowed us to embark on an 8 week formal public consultation to invite comments and feedback upon it from local residents, statutory bodies and other stakeholders in the community, which will end on Friday 10th June 2022. All feedback will be considered by the Parish Council's Steering Group and used to produce a 'Submission' version of the Neighbourhood Plan. Once this is completed, it will be subject to a final round of consultation led this time by Newcastle City Council, followed by an independent Examination to ensure the Plan meets Statutory requirements. The final step of the Neighbourhood Plan process is for the Plan to proceed to a referendum open to all residents of Dinnington Parish. If this results in a majority support for the Plan, it will then be adopted and be used by Newcastle City Council as a statutory document in the determination of planning applications in the Parish.

#### 4.0 PRE-SUBMISSION (REGULATION 14) CONSULTATION

- 4.1 Following completion of the Pre-Submission NP in February 2022, the statutory (Regulation 14) consultation exercise took place over an 8 week period from Monday 18<sup>th</sup> April 2022 to Friday 10<sup>th</sup> June 2022.
- 4.2 The consultation was publicised via a leaflet, circulated to all addresses in the Parish in the week prior to commencement of the consultation. The leaflet included a link to view the Pre-Submission Plan on the Parish Council's website (see Figure 10 overleaf), as well as information on where to view paper copies of the Plan for those without internet access. The leaflet also contained
  - A summary of the main provisions of the Plan (ie its Vision, Objectives and Policies)

- An explanation of the background to the Plan, including a link to the City Council's webpage on neighbourhood planning
- Information about the consultation itself, including how to respond (electronically and by post) and what will happen after the consultation is complete
- Notice of a consultation event, planned as part of the Pre-Submission consultation, which would be taking place in the Village Hall between 10am and 2pm on Saturday 23<sup>rd</sup> April 2022. This was the first weekend of the consultation period.
- 4.3 A full copy of the publicity leaflet is provided at Appendix 4 of this Statement. A publicity poster was also produced, copies of which were put up at various prominent locations in the village including the Post Office, Village Hall and Memorial Institute, the local pub, the village shop and Dinnington Social Club (see Figure 11 below).
- A list of the statutory consultees notified about the Pre-Submission NP<sup>10</sup> is included in Appendix
   and a copy of the notification email/letter itself is at Appendix 6. In addition to the statutory consultees, notification letters and leaflets were also posted to all non-residents with business interests in the Parish (see Appendix 7 for copy of notification email/letter).

#### Outcomes from Pre-Submission (Regulation 14) consultation

4.5 At the close of the consultation, a total of 8 submissions had been received, whilst the public event on 23<sup>rd</sup> April 2022 was attended by 26 people. Appendix 8 contains a table setting out details of the submissions, the responses to them and how (where relevant) they led to changes to the NP<sup>11</sup>.

#### 5.0 CONCLUSION

- 5.1 In light of the evidence provided in this Statement, it is concluded that the process and techniques involved in community engagement were thorough and robust and the results of it have been properly considered and reflected both in the development and final content of the Dinnington Parish Neighbourhood Plan.
- 5.2 Accordingly, it is the conclusion of this Statement that the requirements of the relevant Regulations have been fully met.

#### SO WHAT'S HAPPENING?



#### Neighbourhood Plans

A Neighbourhood Plan is a community-led framework for guiding the future development and growth of an area. It may contain a vision, aims, planning policies, proposals for improving the area or providing new facilities, or allocation of key sites for specific kinds of development.



Neighbourhood plans relate to the use and development of land and associated social, economic and environmental issues. It may deal with a wide range of issues (like housing, employment, heritage and transport) or it may focus on one or two issues that are of particular importance in a local area.

Neighbourhood planning cannot be used to block the building of the homes and businesses considered to be necessary to meet the City's current and future needs. However, you can use it to influence the type, design, location and mix of new development.

A Neighbourhood Plan will be subject to examination and referendum and then form part of the Local Development Plan. This statutory status gives Neighbourhood Plans far more weight than some other local planning documents, such as parish plans, community plans and village design statements.





All feedback will be considered by the Parish Council's Steering Group and used to produce a 'Submission' version of the Neighbourhood Plan. Once this is completed, it will be subject to a final round of consultation led by Newcastle City Council, followed by an independent Examination to ensure the Plan meets statutory requirements.

The final step of the process is for the Plan to proceed to a referendum open to all residents of Dinnington Parish. If this results in a majority support for the Plan, it will then be adopted and be used by Newcastle City Council as a statutory document in the determination of planning applications in the Parish.

#### What is this about?

#### Background to the Dinnington Parish Neighbourhood Plan

Dinnington Parish Council first embarked on the process of preparing a Neighbourhood Plan for the Parish back in 2013. Since then, a Steering Group has helped develop and shape the Plan, supported by a Planning Consultant and Newcastle City Council Planning Officers.

The completed Plan gives voice and fulfilment to the community's aspirations to maintain the essential character, appeal and community vitality of Dinnington as a place to live and work. It does this by setting out a Vision (see front page), together with Objectives, Policies and an explanatory narrative.

Together, these provide a local level, community-led context for the management of development and land use in the Parish for the period 2021 to 2036.

Where opportunities arise to improve the identified assets or provide new community facilities, services or amenities, these will be supported subject to other planning considerations being acceptable.


