Benwell, Scotswood and Denton Burn Ward

Proposal at Consultation: Denton Burn Library, 713 West Road, NE15 7QQ

Comment Received From: Councillor H Stephenson

Comment: "Retaining Denton Burn Methodist Church for the Thorntree Estate from Denton Road upwards and extending its use to accommodate more areas up the West Road to the new boundary. It is accessible for all, as is Denton Burn library further down the West Road, for the Broadwood Estate down to Wood Grove. A lot of elderly who like to vote on the Thorntree Estate and use the church as well as on Broadwood Estate. Both Denton Burn Library and Denton Burn Methodist Church should be kept to reflect that."

(Acting) Returning Officer Response: ARO was happy to keep Denton Burn Methodist Church as opposed to the use of Denton Burn Library following the comments from Cllr Stephenson.

In later discussions with ARO staff, Cllr Stephenson expressed a broader preference for keeping both the library and the church as polling venues.

ARO staff followed this request up with taking a further review of electorate size, historical turnout data and the proximity from the Wood Grove area to both buildings. The ARO is confident that merging polling districts B01 and B02 into a single district with one polling place is sufficient to serve the area.

The approximate walking time between the library and the church is four minutes. While electors who previously voted at the library will now need to cross Denton Road, this was already the case for those living on Howdene Road.

The final recommendation is to implement the proposed changes to the polling district and to continue with the use of Denton Burn Methodist Church as this has previously served a large part of the electorate and is well located within the district.

On this basis this option was discarded.

On this basis this option was discarded.

Comment: "Your suggestion for G04 Northumbria University isn't in the polling district or even in Dene and South Gosforth ward so I don't understand why it has been suggested. Perhaps we could look at a shop at Four Lane Ends or Sutherland Park Rugby Club (Disabled access could be a problem there). Otherwise, would a portacabin not be possible as a temporary measure."

(Acting) Returning Officer Response: The current polling station that serves this group of electors, "Benton Park Primary School" is currently closed for refurbishment and is likely to remain closed at the time of the 2026 polls. It is currently unknown if after the refurbishment the school will be available to use as a polling station again, however the ARO staff will keep this under review.

The process of identifying an alternative building involved exploring all viable options within the surrounding area. Polling district G04 presents limited choices in terms of suitable venues for use as a polling place. The ARO is opposed to the use of temporary units, as they often do not meet essential accessibility standards. Under the Elections Act 2022, AROs must provide sufficient space to carry out ID checks in a private and secure manner. Additionally, the cost of hiring a standard temporary unit typically exceeds £3,000, which is considered excessive. As such, temporary units will only be considered in exceptional circumstances where no suitable alternatives are available.

While Coach Lane Campus does extend across neighbouring boundaries, the section under consideration lies within the Newcastle upon Tyne area. This option would require electors to cross into Manor Park ward. Although this location falls outside the Dene and South Gosforth Ward, Section 18B(2) permits a polling station to be situated outside its polling district if the location "...does not materially affect the convenience of the electors or any body of them."

Ultimately, this is a matter of balancing the suitability of venues found within G04 against the potential benefits of electors travelling slightly beyond the polling district—or even the Local Authority boundary—to access a more appropriate facility.

The ARO staff were unable to speak with the necessary individual at the University to explore this option any further. A site visit to Novocastrians RFC was conducted which considered this building suitable.

Another suggestion is using a shop premises at the Four lane ends which really goes to prove that this area is poorly provided for in community spaces. Could we not use St George's church hall as we currently use one of the rooms for Dene and South Gosforth Ward surgeries once a month."

(Acting) Returning Officer Response: The current polling station that serves this group of electors, "Benton Park Primary School" is currently closed for refurbishment and is likely to remain closed at the time of the 2026 polls. It is currently unknown if after the refurbishment the school will be available to use as a polling station again, however the ARO staff will keep this under review.

The process of identifying an alternative building involved exploring all viable options within the surrounding area. Polling district G04 presents limited choices in terms of suitable venues for use as a polling place. The ARO is opposed to the use of temporary units, as they often fail to meet essential accessibility standards. Under the Elections Act 2022, AROs are required to provide sufficient space to carry out ID checks in a private and secure manner.

Additionally, the cost of hiring a standard temporary unit typically exceeds £3,000, which is deemed excessive. As such, temporary units will only be considered in exceptional circumstances where no suitable alternatives are available.

While Coach Lane Campus does extend across neighbouring boundaries, the section under consideration lies within the Newcastle upon Tyne area. This option would require electors to cross into the adjacent Manor Park ward. Although this location falls outside the Dene and South Gosforth Ward, Section 18B(2) permits a polling station to be situated outside its polling district if the location "...does not materially affect the convenience of the electors or any body of them."

Ultimately, this is a matter of balancing the suitability of venues located within G04 against the potential benefits of electors travelling slightly beyond the polling district—or even the Local Authority boundary—to access a more appropriate facility. The ARO staff were unable to speak with the necessary individual at the University to explore this option any further.

St George's Church is at the far end of the neighbouring polling district and the walking time was around 19 minutes as opposed to 8 minutes to Novocastrians RFC. A site visit determined this building is suitable and is approximately an 8-minute walk from the current polling station.

Osborne Road already provides a clear north and east boundary to the polling district. Moving Hazelwood Avenue, Tavistock Rd and (part of south side of Osborne Road into M02, whilst slightly closer to the polling station, makes the boundary less distinct and easy to communicate to electors.

The combining of North Jesmond and South Jesmond wards allows opportunity to remove confusion at new southern boundary. Including all of Northam Place, along with Lily Avenue, Lily Crescent, Holly Avenue West and east side of Osborne Road (from Lily Avenue to Haldane Terrace bridge) in M01 creates a distinct boundary that also makes the polling station more accessible for residents in these streets."

I much preferred the original suggestion in the pre-consultation of using a portable polling station in front of the shops at the Crossway once again. This is a much more central location within the polling district and will enhance accessibility for all those residents wishing to exercise their right to vote."

(Acting) Returning Officer Response:

The ARO is opposed to the use of temporary units, as they often fail to meet essential accessibility standards. Under the Elections Act 2022, AROs are required to provide sufficient space to carry out ID checks in a private and secure manner.

Additionally, the cost of hiring a standard temporary unit typically exceeds £3,000, which is deemed excessive. As such, temporary units will only be considered in exceptional circumstances where no suitable alternatives are available.

Comment: "I wish to object to the proposed polling districts and polling stations proposed for the ward. My objection stems from two principles.

- other than removal of certain properties from the wards, there have been no other changes or additions to the ward.
- Any change in polling stations always causes voter confusion and it is therefore preferable to avoid them if possible.
 I also note that the proposal does not suggest that any of the existing polling stations are no longer usable and in fact proposes to use them all. I would therefore suggest that there is no need to move from the current Y01-Y04 polling districts and associated polling stations. While this would result in a reduction in voters at one poll, it would otherwise mean that there is minimal disruption to all voters as they would all continue to vote where they have for several years."

(Acting) Returning Officer Response: The ARO must also ensure that each polling station remains within the recommended limit for the number of electors assigned to it. The Electoral Commission's recommended ratio of electors to polling staff is:

0 - 1,250 Electors (1 Presiding Officer and 2 Poll Clerks)
